# **EMPLOYEE RELOCATION INCENTIVE FOR COMPANIES**

# FINANCIAL INCENTIVE FOR COMPANIES

**Applies to the relocation of both foreign nationals\* and Lithuanian expats**


Employers of all eligible relocated specialists can apply for the incentive no sooner than **12 months** but no later than **2 years** after the relocated specialist starts working at the company.

Relocation to Lithuania and application for the financial incentive must take place **between January 1<sup>st</sup> of 2022 and May 31<sup>st</sup> of 2025**.

\* - except Ukrainian citizens.


**up to 6 652 EUR**

The financial incentive is paid to employers to compensate the costs of attracting highly-skilled employees from abroad.



# INCENTIVE ROADMAP

Hire an employee to work in Lithuania



Retain the employee for at least 12 months

Apply for the incentive  
no later than 2 years after relocating or by May 31<sup>st</sup>, 2025

Relocate the employee to Lithuania








**Has a non-fixed term (open-ended) employment contract with a company based in Lithuania.**



**Works in a profession that is on the high value-adding professions shortage list.**



**Receives a gross monthly salary of at least 3 788 EUR.**


If the company's average salary in the previous calendar year was higher, the employee's salary must not be lower than the company's average.



# EXCEPTION TO EMPLOYEE ELIGIBILITY



**In some cases when an employee received a national visa before June 30th, 2022, the financial incentive does not apply.**



# INCENTIVE DOES NOT APPLY TO COMPANIES FOR ATTRACTING UKRAINIAN EMPLOYEES

Lithuania stands firmly with Ukraine and has set up simplified mechanisms to employ Ukrainians. However, the financial incentive does not apply to companies.



# **INCENTIVE DOES NOT APPLY TO COMPANIES FOR ATTRACTING EMPLOYEES WITHIN THE GROUP OF COMPANIES**

The incentive is meant for newly hired employees and not for those relocating within a group of companies or for those who had been employed within the group of companies in the last 5 years.





# EXCEPTION FOR ELIGIBLE COMPANIES

## **De minimis rule**

This financial incentive falls under the concept of de minimis aid. Therefore, the maximum amount of de minimis governmental aid per undertaking over a period of three tax years may not be higher than 200 000 EUR.


